## Section S2: Exemplary semi-structured interview guide

Introduction:

- May I audio record the interview?

General questions:

- Are people able to evacuate themselves in the event of flooding?

- Have you ever experienced difficulties in taking people with disabilities into account in disasters?
- In your opinion, are your employees adequately trained?
- Do you also practise a possible evacuation with your clients?

#### Collaboration:

- What has your experience been working with disaster management authorities on developing inclusive disaster management measures?
  - o What recommendations do you have for more effective cooperation between disability organisations and disaster management authorities?
- Do you know of any opportunities to get involved in the development and decision-making processes for disaster management measures?
  - o Are you participating in the Tyrolean Action Plan?

#### Awareness:

- How could awareness of the requirements of people with disabilities be raised in the civil protection sector?
- What training measures could be implemented to improve sensitivity and understanding of the requirements of people with disabilities in context of disasters?

#### Inclusive disaster risk management:

- What do you understand by inclusive disaster management?
  - o What does it encompass?
- Where do you see your contribution to inclusive disaster management?
- What do you think stands in the way of inclusive disaster management?

#### Conclusion:

- Is there anything else that is important to you that has not yet been mentioned?
