#### SI 3: Employment and value added effects for a range of thresholds

The magnitude of employment and value-added losses is expressed as  $\log_{10}|\Delta Q|$  and visualised as lines on a grey scale. Each line represents one of the 34 sectors in each region, in the sequence order listed in *SI 1*. The figures show that whilst only a few industries were directly affected by the initial damage from the cyclone (black stripes in Fig. 3), many more industries were affected indirectly.




















